Giving the welcome address, the Country Director of SOLTHIS, Maurice Kwite said the SHARE project aims to address and strengthening lessons learnt from other projects they have implemented.

He said they are doing so to make sure that what they are implementing has the required impacts on the lives of the people of Sierra Leone.

Isaac Ahemensah, the UNAIDS Country Director, in his good will message said the project will further strengthen the Country national health systems which was lacking in the national response, emphasizing that the need for a learning mechanism in implementing the national response and maintained the lessons learnt from the implementation.

He commended all development partners in the HIV and AIDS fight noting that the need to have a tool that will assess further project.

Officially launching the project, Dr Alie Wurie, Deputy Chief Medical Officer applauded SOLTHIS for supporting people living with HIV in the Country and assured that the Ministry will continue to work with them citing the 12 years relationship they had shared.

Presenting an overview of the Project, Kazeem Ayankola, Project Coordinator said the project duration is 2 years - July 2023 to June 2025, and the beneficiaries are NETHIPS and other relevant CSOs, DHMTs, Health Care Workers, Support Groups and RoCs.

He mentioned that the project is being funded by the French Development Agency Group and that the intervention areas are National and seven districts. He went on to give the objectives of the project, SOLTHIS experiences considered for knowledge generation, lessons learnt and components explore.
